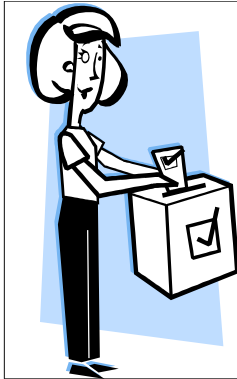

A recipe from Secretary Debby Heidbreder



Strawberry Whipped Sensation

4 cups fresh strawberries, divided
1 can (14oz) Sweetened Condensed Milk
1/4 cup lemon juice
1 tub (8oz) whipped topping, thawed, divided
8 Chocolate sandwich cookies, finely chopped
1 tbs. Butter melted

Line 9X5 inch pan with foil, with ends of foil extending over sides. Mash 2 cups of the strawberries in large bowl. Add condensed milk, juice and 2 cups of the whipped toping; mix well. Pour into prepared pan.

Mix chopped cookies and butter. Spoon over whipped toping mixture. Cover with ends of foil and gently press cookie mixture into whipped toping mixture. Freeze 6 hours or until firm.

Invert dessert onto serving plate when ready to serve; remove pan and foil. Spread remaining whipped toping onto top and sides, slice remaining 2 cups strawberries; arrange over dessert. Store leftovers in freezer.
